These companies may request pre-payment, may not book the room as advertised and may be a scam to obtain your financial information. Do not book with or give your financial information to any housing company except our official housing bureau, MCI USA.

Reservation dates to note (all times Central):

- Reservations will be accepted based on availability until 10am, June 11, 2019.
- Changes to hotel reservations may be made online until 10am, June 11, 2019.
- A deposit of one night's room and tax will be charged at the time a reservation is made.
- The full booking deposit will be refunded for reservations cancelled by May 20, 2019.
- Cancellations made after 10am, June 11, 2019, must be made directly with the hotel and may be charged an additional fee by the hotel.
